1. Who is responsible for the processing of your data?

Why and for what do we treat your personal data?

The company **Luis Rubí, S.L.** treat your personal data with the following purposes:

a) Aims based on the legitimate interest of the company.

In **Luis Rubí, S.L.**, we treat the information provided by interested persons and users, in order to manage the delivery of the information they request, as well as to provide users and interested parties with offers, comments and updates on our products.

In order to be able to offer you the best service according to your interests and improve your user experience, we can, if it were the case, develop commercial profiles, based on the requested information. No automated decisions will be made based on that profile.

b) Purposes that require your consent.

We will need your consent for the submission of offers, marketing, advertising and management of your user data.

We will need your consent for the transfer of data to third parties that is important to be able to exercise our activity, and always within the current legislation. The cession will only be made for the purposes for which each treatment manager has been hired.

2. How do we obtain your data.

The company **Luis Rubí, S.L.**, obtains the data of the information that you provide us when you buy our application or register in it. Likewise, we obtain information about your data when you browse our website and accept our cookies policy.

The categories of data that are treated are:

- Identification data. (Name, Surname, ID number).
- Codes or identification keys.
- Postal or electronic addresses.
- Commercial information.

Specially protected data is not processed.

3. How much time will we keep your data.

Your personal data will be blocked when they are no longer necessary for the purpose for which they were collected, being exclusively available to Judges and Tribunals, the Public Ministry or the competent Public Administrations. in particular the data protection authorities.

these. Once the aforementioned period has elapsed, the company Luis Rubí, S.L. will proceed to delete your data.

4. Who will receive your data.

The company Luis Rubí, S.L. communicates your personal data to:

- 1.- Competent public bodies, Tax Agency, Judges and Courts, when the company has a legal obligation to provide them.
- 2.- Companies that perform the accounting, tax and labor management of the company, with the purpose of performing the functions inherent to the assignment.
- 3.- Luis Rubí, S.L., also has binding corporate rules approved by the European Data Protection Committee.

5. What are your rights when you provide us with your data?

According to the General Data Protection Regulations, you can exercise the following rights:

- Opposition.
- Access
- Rectification.
- Suppression.
- Limitation.
- Portability
- Not being the subject of a decision based solely on automated processing of your data.
- Revocation of the consent given.
